As the Senior Clinical Lead for Emergency Access I reported directly to the Chief Operating Officer, and am responsible for the delivery of the programme for compliance with emergency access target. This role took me from my traditional role in radiology and integrated me into clinical management. The emergency access target remains a challenge and requires a careful operational and strategic approach.

I have also chaired the working party for the development of the Integrated Assessment unit, part of the re-development of the main hospital campus

Clinical Lead for Radiology, United Bristol Healthcare Trust June 2005 – July 2008

As Clinical Lead for radiology I radically improved the delivery of radiological services in UBHT.

I completely restructured CT services within UBHT, with the introduction of a dedicated In-patient scanner. These changes directly resulted in a 18-week reduction in out-patient waiting times, and a same day scanning service for in-patients. I changed methods of working and led initiatives resulting in a reduction of waiting times with no routine lists outside the

government targets. As services became 'list compliant' I initiated and managed a review of service delivery to build on this improvement and maintain efficiency within the department. These service reviews have involved all aspects of the department and are challenging traditional ways of working. I have changed working patterns, encompassed skill mix and allowed role development for all health care professionals. An example of this is the training of radiographic helpers to provide an obstetric ultrasound dating scan service, introduced successfully in February 2007

I have overseen a major review in the department changing the management structure of the radiographers from 22 Superintendents to 4 Section Heads.

In addition, I managed 20 Consultant Radiologists

I am an active member of the South West Cancer Intelligence service and recently completed and published an audit of the standards of imaging throughout the 5 networks covered by this group.

RESEARCH GRANTS

1. Non-alcoholic fatty liver disease in Avon Longitudinal Study of Parents & Children (ALSPAC)

Summary

We have obtained funds to examine the identification, occurrence and risk factors for non-alcoholic fatty liver disease (NAFLD) in a healthy cohort of young adults. The research will be conducted in the Avon Longitudinal Study of Parents and Children (ALSPAC) a prospective cohort study that recruited ~14,000 pregnant women in the early 1990s and has followed-up these mothers, their partners and their offspring since that time. A large amount of lifestyle, genetic and phenotypic (including repeat measurements of fat mass, blood pressure, lipids, insulin, glucose and inflammatory markers) data have been collected on the offspring. Our research will add detailed measurements of liver and spleen at age 17-18 years to these existing data.
