HSE recognises the use of e-learning as a viable learning method, among others, for the delivery of information, instruction and training in relation to asbestos awareness training, provided the course content satisfies the objectives as stipulated in Regulation 10 of the Control of Asbestos Regulations 2012 and the supporting Approved Code of Practice. Ferncroft Environmental's e-learning course has been verified and audited by UKATA before being certified as compliant by them.

Is asbestos training a legal requirement

YES ! The current Regulations place a legal duty on employers to provide information, instruction and training to any of their employees who are likely to be exposed to asbestos as part of their work. HSE advises that annual asbestos training is a mandatory requirement.

The three main types of information, instruction and training are, asbestos awareness training, training for non-licensable asbestos work and training for licensable asbestos work.
